LETTER FROM THE CHAIRMAN -

As I write this letter (at the end of August), the developers for Westfield Farm have not (yet?) appealed against the rejection by ERYC.

There is currently a vacancy on the Parish Council and we are following the specified procedure in such circumstances. There may be an election, or the Parish Council may look to co-opt someone, to fill that vacancy depending on the outcome of the specified procedure. It may be that, by the time you read this, this process has concluded – if so, sorry!

Can I suggest that, if you are interested in helping our local community by becoming a Parish Councillor, you check the Parish Council website regularly or follow our Facebook page (to be sure that you don't miss this or future opportunities). You are of course welcome to contact me, the Clerk or any member of the Parish Council to find out what the role entails.

I know that the issue of dog fouling and general litter is a regular cause for concern. A dog warden recently issued a fixed penalty notice in the village for "failure to clear up after a dog has fouled". I mention this in the hope that every single dog owner does what the vast majority already do, clean up after their dog! Some litter bins that are in poor condition are being replaced and another

new bin is being sited near to the cut through between Mere Way and The Spinney in light of a number of complaints about litter being dropped in that area.

I mentioned in my last letter that the building of houses continued to be a major political issue and I thought I would repeat some of what I wrote then as it is still very relevant.

I think there is a widespread misapprehension about the ERYC Local Plan with the assumption that ERYC (and the Parish Council) have produced this Plan because they actively support building 10%+ more houses in the village. The opposite is the case.

Without a Local Plan there would nothing to stop housing developments in any area in or around the village. In addition to 'encouraging' the production of local plans in this way, government also specified that there should be a housing increase of 10% in every local authority area.

ERYC (with the support of Parish Councils) tried to restrict this to 5% in small villages such as Swanland but this was overthrown by a Planning Inspector and 10% imposed. Even with this increase some developers have still then applied to develop additional areas outside of the Local Plan, such as at Westfield Farm.

The Parish Council do not approve and are not able to reject planning applications but can only comment on them – as can every resident.

ERYC do reject applications taking into account national policy, set by national government, and recent decisions. Clearly, it would be waste of your and my money if they rejected an application knowing that an appeal to the Planning Inspectorate would be successful and incur substantial legal costs to the ERYC.

The Parish Council does have an emergency plan, which is primarily intended for a, hopefully extremely unlikely, occasion when the village was cut off from help from the emergency and other services. This is in the process of being reviewed. It is simply a plan for how to initially react and set up a coordination group, as subsequent actions will clearly depend on the exact circumstances at the time.

The initial group will be Parish Councillors but we would be interested to know of any in the village who would be willing to be on a 'call-out' list if additional people were needed to assist with whatever might transpire. This would simply be a list of names, telephone numbers, addresses and (ideally) email addresses retained by the Clerk (and not publicly available) for use if ever needed. If you wanted to make yourself available in this way, please contact the Clerk.

Let's hope the good weather over the August Bank Holiday continues a little longer!
