

THE EAST RIDING OF YORKSHIRE COUNCIL
(Proposed Experimental Traffic Regulation Order:
20mph zonal speed limit various streets, Swanland
30mph speed limit extension on Dale Road, Swanland.)
ORDER [2025]

1. The East Riding of Yorkshire Council propose to make an Experimental Traffic Regulation Order the effect of which will be to:
 - prohibit vehicles from proceeding at a speed exceeding 20mph on various streets, Swanland as listed below.
 - prohibit vehicles from proceeding at a speed exceeding 30mph on Dale Road, Swanland, measured between a point starting 26m north of the junction with Westerdale to a point measured 309m north of the junction with Westerdale.
2. The order will be experimental and will be operative from 27 March 2025 for a period of 18 months, with the intention of making a permanent order immediately following the 18-month period. Any objections will be included for consideration before a decision is made whether to make a permanent order.
3. A copy of the Experimental Order, the associated plan, and the Council's Statement of Reasons are available for inspection at Brough, Anlaby and Hessle Customer Service Centre during normal office hours. A copy of the street notice and relevant plan have been placed on the Council's website (East Riding of Yorkshire Council, Traffic Management and Road Safety).
